# The Analysis of Hong Kong SAR Legislation Supervision System

Hong Kong basic law has great influence to Chinese legislation system, it has formed the supervision system of the central government to SAR, but this system has different defects in the theory and operation. The problems of unconfirmed supervision standard, conflict and insufficient method of recording supervision seriously affect the real efficiency of the supervision system. From "one country two systems" and innovated theory, this article proposed several suggestions for prefects Hong Kong legislation supervision system: protects the basic law authority and from the foundation of rightly considering the division of the central government and local authorities, build the new supervision model of jurisdiction system that uses the highest court's violation of the Constitution examination as core.

### Discussion of the Institution of Execution Procedure on the Code of Civil Procedure of Macau

Ho Chi Un (pp. 451)

This article mainly provides a summary of the following points regarding the current institution of execution procedure stipulated by the Code of Civil Procedure of Macau: the forms of execution procedure, its legitimacy, the title of execution, the defensive manner of executed parte, the seizure, the payment phase, the judicial sale, etc. Among these, it is worth to raise the question of the legitimacy on the action for execution between spouses as it involves concerns about compatibility between the civil law and the civil procedure law. In addition, a number of modifications have

been made to the law on judicial sale, abolishing judicial sale in the form of public auction and only permitting judicial sale in the form of proposal for closed bid. Finally, as stated by a Portuguese legal scholar, "the civil procedure law is to serve the civil law". The procedure law should aim at implementing the substantive law, while the institution of execution procedure should not be an exception.

# Macao's Secondary education: Comparing General Schools and Technical-Vocational Schools

### Social Relief Activities and Authority System: the Origin of Museum of the Holy House of Mercy

Since the beginning of the Christian Church, even in the time of the persecutions, there was already the service of assistance and protection to the poor people, repenting women, etc. With the freedom granted to the Church by the Roman Emperor Constantine was more extended the assistance to the people in need. Later, with the diffusion of Religious Orders, in the East and the West, they had created Confrarias and Brotherhoods. Thus, it started to exist an institutional assistance (Hospitals and Brotherhoods) and a charity without institutions, from one person to other one.D. Leonor, sister of the king of Portugal, D. Manuel I, on the 15th August 1498, she inaugurated

the Brotherhood of Our Lady of the Mercy. The new Brotherhood quickly extended over the whole the European territory of Portugal and Portuguese Overseas Colonies. In Macau, the Mercy is supposed to have been established in 1569 by the Jesuit Bishop Melchior Carneiro, who soon created the Hospital of the Poor, as well as an Isolation hospital to assist to the lepers, the Hospital of S. Lazarus, as well others institutions. Even nowadays, it still plays an important role in the assistance to the people in need.
