An Empirical Study of the Life Stress of Inclusive Students' Parents in Macau

Tong Chi Man Lee Sung Yi Sze Tat Ming (pp. 179)

The purpose of this study is to explore the current situation of the life stress of inclusive students' parents in Macau, and understand the differences of parents' life stress in different contexts. The study included 337 inclusive students' parents, and statistics were performed using single-sample T-test, independent sample T-test, and one-way anova. The results show: 1)Parent's overall life stress is lower level, and their life stress such as "life experience", "interpersonal experience" level is also lower level; 2)Four background variables of the "parent-child relationship", "parent age", "relationship with spouse" and "type of child's disorder", have significant differences in parenting stress (P<.05). At last, make recommendations based on the results of this study as a reference for parents, schools and governments.

The Stanton affair, an alliance of the Portuguese and Chinese elites of Macao

During the opium war (1839-1842) Macao faced several crises that put the establishment at risk against the two belligerent powers, China and Great Britain. With this short article, I intend to analyze one of these critical moments and how it culminated in a military intervention at the gates of Macao. We will see how the abduction of a British man can raise the whole question of the limits of the establishment as well as its jurisdiction.

With this article, we can see how the Holle affair proceded, and most important the different views of the jurisdiction of the establishment. The first one is the Chinese dictated by a close foreign policy and a strick claim to the rent territory. Secondly, the Portuguese points of view that saw Macau as theirs and seek to challenge the Chinese jurisdiction in every turn.

Another intriguing aspect is the constant political and military pressure by the British forces, that sought any justification for placing military personnel in Macao and claiming the city as their own. It is then a policy of collaboration between the Chinese and Portuguese authorities that will seek to avoid a British military intervention in the city.
