The Development of Macao's Emergency Management System in Public Health in the past ten years after handover

By the end of the 20th century, Macao's public health system was characterized by great achievements in healthcare. As to the emergency management system in public health, there were obvious vulnerabilities due to various factors such as population, environment, behavior and health system.

Since the beginning of the 21st century, Macao SAR has successively survived three severe public health threats, i.e., the outbreak of dengue fever, the emergency of severe acute respiratory syndrome (SARS) and the threat of avian and pandemic influenza. Macao emergency response capacity has been continuously and markedly enhanced in the process of these three threats. Especially important milestones of development have been achieved in six key aspects, namely policy, law, organization, capacity, community and networking. Core capacity building in public health should be the key task in the development of Macao healthcare system. Three frameworks should be adopted for the public health emergency response capacity building: the International Health Regulations (2005) and the World Health Organization Asia Pacific Strategy for Emerging Diseases (APSED) as a direction guide; the Chinese "PLOM framework" - Preparedness plan, Legal system, Organizational system, Mechanisms of operation - which has led to great success in mainland China as a strategy guide; the methodology of risk management as a technical and procedural guide.

The Construction of New Labor Order under the New "Labor Relation Act" in Macau: A thought on doing private business via internet during working hours

With permeating of computer and internet in our work life, the problem of doing personal business via internet in working time becomes a common occurrence. The labor law has established a series of legal system to guarantee the initiative role of employers in the employment relation and tries to keep a balance between the employees an employer. The Nature of Pretrial Custody in Portuguese Code of Criminal Procedure

This paper discusses the nature of pretrial custody in the Portuguese criminal justice system. From the birth of the first Portuguese democratic constitution, the retention measure was set as an exceptional coercive measure, which means that when the use of coercive measures against the suspect is deemed to be necessary, the first choice should be the one resulted in least damage to the suspect's rights and freedoms. In addition, the rash detention measures should not be taken against the suspect without considering the circumstances of specific cases, and the principle of proportionality should be strictly abided even if it is justified to support the measures.

The Dilemmas of Whistle-Blowing

Whistle-Blowing is an institutional arrangement in administrative supervision system. The legitimacy of Whistle-blowing roots deeply in the political theory of natural law and social contract. From the moral aspects, the moral dilemma of whistle-blowing arises from the conflict between subject responsibility and object responsibility. The author argues that dilemmas of whistle-blowing came from the lack of public spirit, the insufficient safeguard and incentive system as well as the monopoly of public officials on "legitimate violence". The author raises three way out of the dilemma, namely, regarding public officials as "complex man"; realizing the evil nature of the power; and getting "incentives" right.

The Transition of Science and Technology and the Policy Reform: on how the regulators should respond to the media convergence
